Dear Ms. Stein:

We need your help. We are deeply troubled by the Bridger-Teton National Forest Service (BTNF) plans to sell a large portion of our public land in downtown Jackson for unspecified real-estate development and to use proceeds to expand housing onto virgin forest lands that boarder East Jackson.

This East Jackson development will spread housing up the hillside at the Putt-Putt trailhead, destroying no less than 4.3 acres and adding 26 additional units. It more than doubles the existing footprint, ignores significant environmental impacts, creates unnecessary sprawl and lacks any objective data as justification. Moreover, it flies in the face of well-established community values for preserving open spaces and respecting wildlife habitat.

We need your help. Our first priority is to convince local elected officials not to weigh-in on this project, at least not yet. The BTNF presented its plans to the joint meeting of the Town Council and County Commission on August 3, 2009, hoping for a quick stamp of approval.
